Whereas the draft of the following rules further to amend the Karnataka Medical Registration Rules, 1963 which the Government of Karnataka proposes to make in exercise of the powers conferred by section 31 of the Karnataka Medical Registration Act, 1961 (Karnataka Act 34 of 1961) in Notification No. HFW 07 RGU 2017, Dated: 21st January 2019, in part-IV-A of Karnataka Gazette dated 24th January 2019, inviting objections or suggestions from persons likely to be affected thereby, within 15 days from the date of its publication in the Official Gazette.

Whereas, the said Gazette was made available to the public on 24th January 2019. And whereas, objections / suggestions were received by the State Government, after careful consideration of the objection/suggestions Government has taken a decision to reject the same with detailed explanation.

Now, therefore, in exercise of the powers conferred by section 31 of the Karnataka Medical Registration Act, 1961 (Karnataka Act 34 of 1961) the Government of Karnataka, hereby makes the following rules namely: -

RULES

1. Title and commencement.- (1) These rules may be called the Karnataka Medical Registration (Amendment) Rules, 2018.

(2) They shall come into force from the date of their final publication in the official Gazette.

2. Amendment of rule 4.- In rule 4 of the Karnataka Medical Registration Rules, 1963 (herein after referred to as the said rules),-

(i) for sub-rule (1), the following shall be substituted, namely:-

"(1) The list of Medical practitioners registered under the Act referred to in clause (a) and clause (b) of sub-section (2) of section 3 of the Act. An Officer of the Department of Co-operative Societies not below the rank of Additional Registrar or Joint Registrar of Co-operative Societies or KAS Officer (Senior Scale) shall be the returning Officer.

(1A) The list of Medical practitioners published under sub-section (1) of section 26 of the Act in the year in which elections are to be held shall, constitute the preliminary electoral roll for the purpose of election of members under clause (a) of sub-section (2) of section 3 of the Act:

Provided that, a separate Electoral Roll shall be maintained Revenue Division wise as per their address mentioned in the Medical Council Ledger."
