2. I state that I am aware of the Karnataka Compulsory Service Training by Candidates Completed Medical Courses Act, 2012, (hereinafter, the "Impugned Act") and the Rules thereunder passed by the Karnataka State Legislature.
3. I state that I am also aware that the Hon'ble High Court of Karnataka, at Bengaluru *vide* Order dated 06.10.2015 in W.P.No.40566/2015 and connected matters, has stayed the operation of the Impugned Act and also all further proceedings, orders, actions notifications including the Rules, etc., pursuant to the said Act.
4. I further submit that the Hon'ble High Court of Karnataka. *Vide* order dated 28.04.2016 in W.P.No.25391/2016 has directed the concerned Universities to issue appropriate Degree to the eligible candidates. Further the Hon'ble High Court has directed the Karnataka Medical Council to grant registration certificates to the eligible students/doctors, subject to the result of the aforementioned writ petitions, contingent upon the said candidates/doctors filing an Affidavit before the Karnataka Medical Council that they will abide by the order which may be passed in W.P.No.40566/2015 and connected matters, without demur i.e., to comply with the provisions of the Impugned Act, (Karnataka Act No.26 of 2015) in the event of failure in the aforementioned writ petitions.
